Sir,

This refers to your proposal/ letter dated 11th December, 2017 for correction in the Environment Clearance to the above mentioned project granted by this Ministry vide letter dated 20th March, 2017.

2. The corrections have been sought in the environmental clearance with the details as under:

3. On examination of the proposal in the Ministry, it has been observed that the desired changes in the said environmental clearance, as at S. No. 1, 2, 3 & 4 of the table at para 2, are infact corrections, based on factual information. However, in case of item at S. No. 5 regarding green belt, the request was not found admissible due to non applicability of the condition as reported.


4. In view of the above, the Ministry of Environment, Forest and Climate Change hereby accords approval to the corrections in the environmental clearance dated 20th March, 2017 to the above project, for the items at S. No.1,2,3 & 4 of the table at para 2.

5. All other terms and conditions stipulated in the environmental clearance dated 20th March, 2017 shall remain unchanged.
