We thank the applicants for responding to Advertisement No. NRPL/HR /Rectt./2013 notified by us on 10<sup>th</sup> December 2014.

Candidates whose applications were incomplete or were received after due date or did not meet the eligibility criteria were summarily rejected. Further, since a large number of applications were received, we were constrained to short-list the candidates for written test based on the minimum percentage of cut-off marks in the prescribed qualification, as was also mentioned in our notification dated 10.12.2014.

We are uploading the details of candidates who have been short-listed for written test on the website. The admit cards will be despatched to these short-listed candidates through ordinary post at their respective correspondence address latest by 10.03.2015.

The written test for the notified vacancies would be conducted on 5<sup>th</sup> April 2015 at Arya P.G. College, Opp. Bus stand, Panipat (Haryana) from 10 AM to 11 AM. Candidates are advised to report by 0930 AM.

Candidates whose name figures among the short-listed candidates and who do not receive their admit cards by 25<sup>th</sup> March 2015 may inform us about the same at [recruitmentnrpl@indianoil.in](mailto:recruitmentnrpl@indianoil.in) by clearly mentioning their **Name**, **Post applied for** and **Roll Number**. Such requests must be made **between 26<sup>th</sup> and 31<sup>st</sup> March 2015 only**, preferably from the e-mail account mentioned by the candidates in their original applications. We would issue duplicate admit cards to such candidates at the test venue itself, subject to verification from a valid photo identity card like PAN, Driving license, Aadhar card or Voter card. Such candidates would be required to bring additional photographs (matching with those used in the application form) along with all original documents and attested copies thereof in support of their eligibility.

The written test paper would comprise multiple choice questions (MCQs) which will include technical questions, questions of General knowledge and aptitude. Result of the written test would be declared on 5<sup>th</sup> April 2015 itself at the test venue around 1730 hrs.

Candidates may note that based on their performance in the written test on 5<sup>th</sup> April 2015, they would be further short-listed for Trade test (Physical fitness test for Technical Attendant-I) and interview. For such candidates, the Trade test/Physical fitness test & interview would be conducted at Panipat itself on 6<sup>th</sup> and 7<sup>th</sup> April 2015, therefore outstation candidates may plan their travel accordingly. Please note that no boarding/lodging would be provided by IOCL to such candidates.
