(Pipelines Division) is seeking applications in Two Bid System i.e. Technical Bid (Part – I) and Price Bid (Part-II) from interested land /Firm owners who are willing to give their land/Firm on Hire for establishing Open and Closed Space for storage yard in **Morena district** for CGD project.

**Pre-Requisites:**

1. Open yard with proper boundary wall/ fencing.
2. The open yard should be able to ply hydra, trailers etc. and storage of steel pipes etc and should have plain and levelled surface.
3. Land area should be freehold and free from all encumbrances with clear title deed.
4. Land should be located within 20 KM from city center (Barrier Chowk), over the SH/NH in the respective districts.
5. Land should have all weather access & suitable for movement of heavy vehicles like trailer, hydra etc.
6. Premises should have provision for water, power supply, lights, toilet and guard room.
7. Covered Yard should be suitable for movement of forklift, Hydra crane and easily accessible for long body Trailer Movement.

**Interested owners are required to apply for open and closed storage yards with the following details in two bid system as mentioned below:**

**Technical Bid (Part – I):** To be submitted in separate sealed envelope consisting of following documents **other than cost offered** for the land:-

1. Relevant documents towards possessing the facility yard & warehouse.
2. Name of owner/Firm

**Price Bid (Part – II):** To be submitted in separate sealed envelope consisting of:-

1. Cost of offered land (Total cost per month).

The two sealed envelopes containing the Technical Bid (Part-I) & Price Bid (Part-II) should be put together in a large envelope duly sealed with Name and Address for Open storage yard and closed Storage yard, as applicable.
