(Pipelines Division) is seeking application in Two Bid System i.e., Technical Bid (Part-I) and Price Bid (Part-II) from interested landowners who are willing to sell their land for establishing Sectionalizing Valves (SV) for Mundra Panipat Crude Oil Pipeline (P-25) (New MPPL) of size 35m X 35m (1225 sqm) in the below villages and its nearby villages in **Gujarat**:

**Pre-Requisites:**

1. The offered land must be in a single plot or in contiguous plot.
2. The land must be connected with approach road.
3. Land must be free from all encumbrances.
4. No public utility like HT line/Sewerage line/Oil or water pipeline or canal/Public Road/Rail line/Crematorium/burial ground etc. should exist in the offered land.
5. In case of group of owners having land measuring approx. 1225 sqm for SV station, they may apply in single envelope as one offer.
6. The land must be located on the alignment of New MPPL Project. The details of pipeline alignment may be collected from our office (Address is mentioned below), if required.

**Price Bid (Part-II):** To be submitted in separate envelope consisting of:

1. Cost of offered land (Cost per Sq. meter as well as Total cost)

**The cost offered by the party shall not appear in any manner in the Part-I (Technical Bid).
