Instructions to the candidates provisionally shortlisted for appearing in the Personal Interview

- The candidates should appear for the Personal Interview strictly as per the schedule mentioned above.
- The candidature of all the shortlisted candidates are provisional and subject to their meeting the prescribed eligibility criteria as notified vide our advertisement and subsequent letters to the candidates. In case, any of the candidates do not meet the prescribed eligibility criteria, they are requested not to appear for the Personal Interview.
- The candidature of any candidate is liable to be cancelled if at any stage it is found that he/she does not meet the prescribed eligibility criteria.
- Merely getting shortlisted for the Personal Interview does not confer any right for engagement.
- Candidates are required to bring with them the call letter for interview sent to the candidates through e-mail along with all certificates / testimonials / mark-sheets in original pertaining to your qualification, age, date of declaration of result (applicable for post code A4 to A7) etc and one set of self attested photocopy of the same along with their original application (emailed to us for Engagement as Apprentices) and two recent passport size photograph.

Note : In case the date of Declaration of result of the Diploma Course passed by the candidate is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College /Institute from where the candidate pursued his/her Diploma course

- Candidates are required to bring a valid Photo – ID proof along with their call letter for appearing in the personal interview.
- Candidates belonging to the SC/ ST/ OBC / PWD shall be required to produce their caste / disability certificate issued by the Competent Authority specified by the Govt. of India (Ministry of Social Justice & Empowerment). The name of caste / community to which the candidate belongs must appear in the Presidential Order / Gazette Notification issued by Govt. of India.

- For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the proforma prescribed by Govt. Of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (Creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt. (SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Accordingly such candidates may choose to apply for the positions provided they meet the age criteria applicable to UR Candidates and indicate their category as 'UR'. Indian Oil Corporation Ltd. (Guwahati Refinery) being a Central Public Sector Undertaking, only those communities that are mentioned in the common list of OBC approved by Central Government shall be treated as OBC for the purpose of reservation.
- SC/ST/PWD candidates appearing for interview will be reimbursed single second class railway fare from the nearest railway station of the mailing address to the place of test/interview and back by the shortest route on production of ticket, provided the distance is not less than 30 KMs.
