Proper record and account of measures taken should be maintained and should also be submitted to the CZMA every six months.	(1) Fund of Rs. 48.90 lakh has been released for providing 4 vehicles (Boleros) to SP office, Jagatsinghpur District under CER Projects of PHPL. (2) Proposal for adoption of Indian one-horned Rhinoceros in Indira Gandhi Zoological Park, Visakhapatnam district for 3 years at cost Rs. of 9 lakh has been accorded on 28.01.2022 and subsequently fund of Rs. 3 lakh has been released for one year. (3) Work initiated for the project 'Installation of solar lights and high mast lights in revenue villages Patana, Mahala, Gobindpur, & Trilochanpur of Erasama Block in Jagatsinghpur District of Odisha' under CER, at total estimated cost of Rs. 50 Lakh. (4) Work initiated for the project 'Facilitating the necessary needs of animal welfare incl. additional night houses for Indian Rhinoceros, Striped Hyena & Himalayan Black Bear, Aviaries refurbishment Visitor amenities, and Conservation & Outreach activities at Indira Gandhi Zoological Park, Visakhapatnam, Andhra Pradesh' under CER, at total estimated cost of Rs. 1.88 Crore. (5) In-principle approval for earmarking fund of Rs. 50 lakh for development works in revenue village Dinkia of Erasama Block in Jagatsinghpur District under CER Projects of PHPL has been accorded on 22.12.2022.
