  - Mark sheets of all semesters/years of Diploma/ITI/Sub Officers Course

  - Offer of Appointment
  - First and Last pay slip
  - Release Order
  - Experience / Service certificate
  - Apprenticeship training certificates (if applicable)
4. Caste Certificate(applicable for SC/ST/OBC)
  - Caste certificate (applicable for SC/ST/OBC only) in the prescribed format (in the proforma prescribed by the Govt and issued by competent authority only)
5. Others
  - No Objection Certificate from employer (applicable to candidate presently employed in State / Central Govt, PSU, Govt Organization / department or autonomous body)
  - Service certificates and discharge certificate (applicable to ex servicemen only)

- Apart from the specified documents, candidates may upload any relevant documents with respect to various criteria's mentioned in our detailed Advertisement
