All such shortlisted candidates shall bring a copy of Admit Card retained by them and **original documents** <u>along with</u> attested copies of the same for verification at the time of the Skill/ Proficiency/Physical Test, failing which they will not be allowed to appear in the same:

- Two nos. of latest passport size photograph.
- Matriculation/ Higher Secondary or other relevant certificate in support of Proof of Age (PAN Card, Voter ID Card, Passport, Driving License in support of DOB are not acceptable)
- Marks sheet / Certificate starting from Matric, Intermediate, Diploma, ITI as applicable
- Requisite Proof of post qualification experience such as Appointment Offer/Letter and last pay slip or release order from current/latest employer or experience certificate issued by the employer.
- No Objection Certificate from employer in case you are presently employed in Govt. / Semi Govt. / Public Sector Undertaking, if application was not sent through proper channel. In case it is not possible to produce NOC at the time of Skill/Proficiency/Physical Test, in case of selection, you will have to bring clear cut release order from your previous employer at the time of joining.
- Candidates possessing experience of working in a large industrial establishment (industrial/manufacturing units whose investment in plant & machineries exceeds Rs. 10 crores and which has been in operation) are required to submit copy of the relevant page of the last published Balance Sheet of the establishment under self certification by the candidate.
- Candidates who have completed Apprenticeship are required to submit relevant document (s) as proof of their having done the same under the Apprentices Act, 1961 / Apprentices (Amendment) Act, 1973 in the relevant trade/discipline.
- Caste Certificate [ST] / Disability Certificate in the prescribed format as applicable.
- Request for change in the date of Skill/Proficiency/Physical Test will NOT be entertained.
