**Instructions to the candidates provisionally shortlisted for appearing in the SPPT**

- The candidates should appear for the SPPT strictly as per the schedule mentioned above.
- The candidature of all the shortlisted candidates are provisional and subject to their meeting the prescribed eligibility criteria as notified vide our advertisement. In case, any of the candidates do not meet the prescribed eligibility criteria, they are requested not to appear for the SPPT.
- The candidature of any candidate is liable to be cancelled if at any stage it is found that he/she does not meet the prescribed eligibility criteria.

- Merely getting shortlisted for the SPPT does not confer any not confer any right for engagement.
- Candidates are advised to bring all original certificates /Mark Sheets /No Objection Certificate (as applicable) as well as attested copies of Certificates/Mark Sheets, failing which they will not be allowed to appear for the SPPT.
- Candidates must submit a copy of Experience Certificates (s), Apprenticeship Completion Certificate issued by previous employer(s) or copy of Appointment Letter and Last Pay slip, (Copy of Work Order and Proof of working in Large Industrial Establishment ,as applicable are also required to be produced) as a proof of required post qualification experience.
- Candidates belonging to the SC/ ST/ OBC / PWD shall be required to produce their caste / disability certificate issued by the Competent Authority specified by the Govt. of India (Ministry of Social Justice & Empowerment). The name of caste / community to which the candidate belongs must appear in the Presidential Order / Gazette Notification issued by Govt. of India.
- For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the proforma prescribed by Govt. Of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (Creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt. (SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Accordingly such candidates may choose to apply for the positions provided they meet the age criteria applicable to UR Candidates and indicate their category as 'UR'. Indian Oil Corporation Ltd. (Guwahati Refinery) being a Central Public Sector Undertaking, only those communities that are mentioned in the common list of OBC approved by Central Government shall be treated as OBC for the purpose of reservation.
- SC/ST/PWD candidates appearing for interview will be reimbursed single second class railway fare from the nearest railway station of the mailing address to the place of test/interview and back by the shortest route on production of ticket, provided the distance is not less than 30 KMs.
