- The above mentioned Pay Scales are due for revision and the posts carry other allowances/ benefits as admissible under the rules of the Corporation.
- The prescribed period of Apprenticeship training under Apprentices (Amendment) Act 1973 in the relevant discipline if completed successfully shall be treated as experience.
- <u>AGE LIMIT:</u> Minimum 18 years and maximum 32 years as on <u>31/07/2010</u>. For PH candidate's age is relaxable by 10 years for General candidates (Relaxable by 15 years for SC, ST and 13 years for OBC candidates). Age relaxation for Ex-Servicemen is applicable as per rules.
- Eligible candidates appearing for written test/interview shall be reimbursed second-class rail/bus fare by the shortest route as per rules on production of tickets.
- Applicants from Govt./Semi Govt./PSU must apply through proper channel or produce "No objection certificate" at the time of appearing in the written test /interview.
- Applications without supporting documents/incomplete/not fulfilling the prescribed criteria in any respect are liable to be rejected.
- The period of experience/qualification will be determined as on <u>31/07/2010</u>. In case of non-availability of suitable experienced candidates, experience may be relaxed at the discretion of the management.
- <u>Selection Procedure</u>: The selection would be based on Written Test/Trade Test and personal Interview. The candidates will have to pass through each stage including medical fitness successfully for being adjudged suitable for selection.

Civil Hospital satisfying the prescribed disability criteria.
