IndianOil's Pipelines Division owns and operates the largest network of over 10329 kms. crude oil and product pipelines.

The 1302 km long crude oil pipeline from Paradip in Orissa to Barauni in Bihar has 328 km long Paradip-Haldia and 498 km long Haldia-Barauni sections. In addition, the pipeline system include 20 km long offshore pipeline from Single Point Mooring system to tank farm in Paradip. It also has a loopline of 437 km. A total of 19 km dockline also connects the pipeline with two crude oil jetties at Haldia. The crude oil requirement of IndianOil's refineries at Haldia, Barauni and Bongaigaon is transported through this pipeline.

CONCESSION & RELAXATION:

- 1. Upper age relaxation of 3 years to OBC candidates for the post reserved for them. Upper age relaxation of 10 years for physically handicapped candidates. Age relaxation for Ex-servicemen as per rules.
- 2. SC/ST/PWD candidates are exempted from payment of application fee.
- 3. SC/ST candidates called for test/interview will be reimbursed single 2nd class railway fare limited to rail fare from the nearest railway station of the mailing address to the place of test/interview and back by the shortest route, on production of bus ticket/rail ticket provided the distance is not less than 30 kms. each side.

SELECTION METHODOLOGY:

The selection methodology will comprise Written Test, Trade test and Personal Interview of short listed candidates. The candidates will have to pass through each stage including medical fitness successfully for being adjudged as suitable for selection.
