- **Age Limit:** Minimum 18 years and maximum 32 years as on **31/03/2009** (Relaxable by 5 years for SC/ST and 3 years for OBC candidates for the posts reserved for them). Age relaxation applicable for Ex-Serviceman/PH as per Govt. directives.

- **Selection Methodology:** Selection would be based on written test / trade test and personal interview. The candidates will have to pass successfully through each stage of the selection process including medical fitness for being adjudged suitable for selection.
