- The candidates should bring original and **photocopies attested by a gazetted officer**, of original certificates in support of age, educational qualifications, experience and caste (for SC/ST/OBC categories) along with their applications, failing which their candidature is liable to be rejected.
- Candidates serving in Govt. Departments / PSUs are required to bring no objection certificate from his/her employer.
- The period of experience will be determined as on 30.11.2007.
