- **Persons with other disability may also apply against the posts mentioned above.**
- **Disability of the candidates should not be less than 40%.**
- Pay Scales are due for revision and the posts carry other allowances / benefits as admissible under the rules of the Corporation.
- The prescribed period of Apprenticeship training under Apprentices (Amendment) Act 1973 in the relevant discipline if completed Successfully shall be treated as experience.
- Minimum 18 years and maximum 32 years as on 31.07.2008. For PH candidate's age is relaxable by 10 years for General candidates (Relaxable by 15years for SC&ST. and 13 years for OBC candidates). Age relaxation for Ex-Servicemen is applicable as per rules.
- In case large numbers of applications are received, management reserves the right to fix the minimum percentage of cut off marks in the prescribed qualification for selection of candidates.
- Eligible candidates appearing for written test/interview shall be reimbursed second-class rail/bus fare by the shortest route as per rules on production of tickets.
