So the applicant is not meeting the minimum eligibility criteria of scoring minimum 27 marks for eligibility to provide finance.

As per item no 12.1 of application form regarding capability to arrange finance, the applicant has declared that he has only sum of Rs 400000/- in his Savings account for which marks secured are only 5.71. Also, the applicant has declared that he has 3 no of Fixed Deposits in the name of his mother but as the applicant is married; his mother is not in family unit as per IOCL selection guidelines. So the applicant is not meeting the minimum eligibility criteria of scoring minimum 27 marks for eligibility to provide finance.
3	CHANDRAKA NT AMRUTRAO PATIL KALKEKAR	S/o AMRUTRAO SUBHANRAO KALKEKAR	AIDO/NDNE/NANDED /7	1. As per item no 12.1 of application form regarding capability to arrange finance, the applicant has declared that he has only sum of Rs 3,98,310/- in his account and mentioned loan can be arranged from Merchant Bank for Rs 15 lacs. So total marks secured by applicant is only 15.69 (5.69+10). However, there is no letter from Merchant bank submitted. So the applicant is not meeting the minimum eligibility criteria of scoring minimum 27 marks for eligibility to provide finance. 2. As per item no 11A1, the applicant offered own land in the name of Sh vithal Govindrao Kale mentioning relationship with applicant as relative which means that he is not in the family unit of the applicant as per selection guidelines. So, the application is not meeting the eligibility criteria of providing own land for Godown as offered in application form.
