Consolidated stipend is subject to the periodic revision in minimum wages as applicable to a particular location.

- 14. For all discipline codes: The qualification prescribed shall be from a recognized University/Institute <u>as a full time</u>, regular course in relevant disciplines. Qualification acquired through Part-time / Correspondence / Distance Learning mode shall render the candidate ineligible.
- 15. Diploma under recognized Lateral Entry Scheme(Class XII-Sc)/ITI admitted in the second year of Diploma course shall also be considered.
- 16. Reservation for PwBD Candidates for the Discipline Code Code 56/57/58/59/60: To be eligible against reservation for PwBD, the permanent disability should be a minimum of 40% as issued by the Competent Authority in the Disability Certificate. Categories of Disability with a minimum of 40% and above eligible are given below -
 - VH PV : Low Vision (LV) / Partially Blind (PB)
 - HH PH: Partially Deaf
 - OH-PL: Musculosketeletal (OA-one arm affected / OL-One leg affected / OAL-One arm and one leg affected), Leprosy cured, Dwarfism, Acid Attack Victim, Cerebral Palsy
 - MD A combination of the above
- 17. For Discipline Code 56/57/58/59/60: PwBD candidates with less than 40% of permanent disability are NOT eligible. The PwBD candidates are required to submit a Disability Certificate issued by Competent Authority as per the Persons with Disabilities (equal opportunities, Protection of Rights and Full Participation) Amended Rules, 2009, failing which their candidature as PwBD candidates will not be considered. Persons with Disabilities must be capable of performing the task assigned to them/take instructions using suitable aids and appliances.
- 18. The candidates who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in an Industry as per the Apprenticeship Act, 1961/1973 as amended from time to time or job experience for a period of 1 year or more are NOT eligible.
- 19. Applicants who have acquired Diploma in Engineering in the relevant discipline on or after 1st January 2017 only are eligible to apply for Technician Apprentice. i.e. Discipline code 26-55.
- 20. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College/Institute from where the candidate pursued his ITI course/Graduation/Diploma in Engineering, along with his application form.
- Candidates registered with Local / State Employment Exchange(s) / Vocational Rehabilitation Centre for Person with Benchmark Disability (PwBD) and meeting the prescribed eligibility criteria, are required to apply Online, failing which their candidature will not be considered.

- 22. Candidates with qualification acquired through Distance Learning Mode or Part Time Mode or Correspondence mode shall NOT be considered.
- 23. Candidates possessing higher professional qualifications such as B.E or equivalent, MBA or equivalent or MCA / CA/ ICWA, LLB shall NOT be considered. Suppression of information regarding possession or pursuing higher qualification shall render a candidate ineligible for consideration at any stage of selection/termination or any time during engagement.
- B. Age: Minimum 18 years and maximum 24 years as on 31.07..2019 (Relaxable by 5 years for SC/ST i.e. up to a max of 29 yrs., 3 years for OBC i.e. up to a max of 27 yrs., for the posts reserved for them).

Candidates belonging to PwBD categories shall be given age relaxation up to 10 years (up to 15 years for SC/ST and up to 13 years for OBC (Non-Creamy layer) candidates.

C. Period of Apprenticeship Training: As indicated against respective Discipline codes.

D. Selection Methodology:

- 1. The Selection shall be on the basis of performance of the candidates on the basis of marks obtained by them in the Written Test and meeting the notified eligibility criteria.
- 2. The written test will be conducted with Objective Type Multiple Choice Questions(MCQ's) consisting of four options with one correct option.

- The candidates will have to qualify successfully through each stage of the selection process i.e. Written Test (Minimum 40%, relaxable by 5% for candidates from SC/ST/PwBD categories against reserved positions) and Pre-engagement medical fitness for being adjudged suitable for engagement.

E. Concessions /Relaxation:

- SC/ST/PwBD candidates appearing for written test will be reimbursed single second class railway fare from the nearest railway station of the mailing address to the place of test and back by the shortest route on production of ticket, provided the distance is not less than 30 KMs.
- SC/ST/OBC (NCL-Non Creamy Layer) candidates applying for Unreserved (UR) seats shall be considered subject to their fulfilling the standards applicable to candidates belonging to general category.

F. For getting the benefits of reservation under EWS category:

Should not be covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs8.00 lakhs(Rupees Eight lakhs only). Income shall also include income from all sources i.e., salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- 5 acres of agricultural land and above;
- Residential flat of 1000 sq.ft and above;
- Residential plot of 100 sq. yards and above in notified municipalities;

Residential plot of 200 sq.yards and above in areas other than the notified municipalities

ii) The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18

years as also his/her spouse and children below the age of 18 years.

- iv) The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority, The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-I shall only be accepted as proof of candidate's claim as belonging to EWS:
 - District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Additional Deputy Commissioner/ 1 st Class Stipendary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner

Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate

Revenue Officer not below the rank of Tehsildar and

> Sub-Divisional Officer of the area where the candidates and/or his family normally resides.

v) The crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.

Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits.
