DOCUMENTS REQUIRED FOR VERIFICATION

The following original documents along with self-attested copies are required to be furnished at the time of PI:

- 10th pass/ Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- Latest Caste (SC/ST/OBC) / Tribe / Disability certificate of reserved category candidates in the prescribed format issued by the Competent Authority.
- Semester-wise / year-wise mark sheets and Final Certificate of 10th, 12th, Diploma & Full-time Graduation degree.
- Wherever CGPA/OGPA or Letter Grade is awarded in the Graduation degree examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by University/ Institute. The supporting document should also be produced at the time of PI in case the candidate gets shortlisted for PI.

- v) One Passport size colour Photograph (preferably matching with the one used in application form)
- vi) Any other Certificate, if applicable

IMPORTANT

1. Without original documents, candidates shall not be allowed to appear in PI.
