The Terms and Conditions as mentioned in the Admit Card are given below for reference-:

- 1. With reference to our notification for engagement of apprentices under Apprentices Act, 1961 published in Indian Oil website at www.iocl.com on 31/10/2019 under Indian Oil for Careers -> Apprenticeship and at https://plis.indianoilpipelines.in vide Advertisement No. PLHO/HR/ESTB/APPR-2019(2) and thereon, based on the information furnished by you in online portal, you have been short-listed for appearing in Written Test. The date and venue of written test is mentioned above.
- 2. Candidate is advised to once again thoroughly go through the eligibility criteria published on 31/10/2019 in the notification for engagement of apprentices in Pipelines Division of Indian Oil Corporation Ltd. in Indian Oil website at www.iocl.com under Indian Oil for Careers -> Apprenticeship (link https://iocl.com/PeopleCareers/Apprenticeships.aspx) and at https://plis.indianoilpipelines.in (link https://plis.indianoilpipelines.in/PLApprentice/Admin/Advertisement%20File%20Upl oad/4.pdf). Only those candidates need to come for Written Test and subsequent selection process who meet the notified eligibility criteria for the respective

apprentice trade viz qualification, age, nature of disability(for PwBD candidates) etc. as mentioned in notification. If at any stage of selection process, it is found that the candidate is not meeting the eligibility criteria; his/her candidature shall be liable for disqualification.

- 3. Candidates coming late for the Written Exam shall not be allowed to sit in the Written Test after the commencement of the Test.
- 4. Candidates will have the option to take the written test either in Hindi or in English.
- 5. Photograph and signature of candidate should match with photograph and signature uploaded in the portal at the time of submission of application failing which his/her candidature shall be disqualified.
- Selection process shall consist of Written Test. The Detailed selection process is elaborated at point No 7.0 of apprentices notification of Pipelines Division published on 31/10/2019 in iocl.com under Indian Oil for Careers - > Apprenticeship and at https://plis.indianoilpipelines.in.
- 7. Candidates, who are provisionally selected from the Written Test, shall be called for document verification, on a day which shall be published in the IOCL Website iocl.com and <u>https://plis.indianoilpipelines.in</u>. Candidates are advised to come prepared accordingly and make their own arrangement for lodging and boarding if required, for appearing in Written Test/Document Verification.
- 8. This Admit Card should be mandatorily brought to the examination centre and handed over to the Room Invigilator, failing which entry in the examination hall will not be permitted.
- 9. 20 minutes per hour of extra compensatory time in Written Test will be given to the persons with benchmark disabilities mentioned at point no 1.0 (c) of apprentices notification of Pipelines Division published on 31/10/2019 in iocl.com under Indian Oil for Careers -> Apprenticeship and at <a href="https://plis.indianoilpipelines.in">https://plis.indianoilpipelines.in</a>.
- 10. Candidate is required to carry a Photo ID Proof for the Written Test. The original Photo ID shall be checked and verified during Test. A self-attested photocopy of the same shall also be collected along with the Admit Card after the Written Test and Document Verification. Valid Photo ID proof like Aadhar Card, PAN Card, Driving license, Voter ID card, Passport etc. shall only be accepted. Candidates without valid photo ID shall not be allowed to appear in Written Test and Document Verification.
- 11. Candidate should carry one passport size colour photograph, Pencil, Ball Pen (blue or black), Eraser, Sharpener and Scale at the Examination Centre. Carrying of notes or books, calculators, correction fluid, mobile phones, any other communication devices, scanning devices, laptops etc. in the examination hall, are not allowed. Any candidate found in possession of such unauthorized material or indulging in copying or adopting unfair means is liable to be summarily disqualified.
- 12. The result of short-listed candidates for document verification shall be published in the IOCL Website <u>www.iocl.com</u> and <u>https://plis.indianoilpipelines.in</u> preferably on the same day of written test or next day. No separate communication shall be sent to the candidates in this regard.
- 13. Caste/Tribe/disability/income certificate of SC/ST/OBC/PwBD/EWS candidates should be in the prescribed format issued by the Competent Authority.

- 14. Candidates appearing for document verification shall be required to produce Original documents of all educational qualification certificate i.e. marks sheet of all semesters of diploma examination/degree, Diploma/Degree Certificate, Matric certificate for date of birth proof, Caste/Tribe Certificate (for SC/ST/OBC candidates), Disability Certificate for PwBD candidates and income certificate for EWS candidates etc. along with one set of self-attested photocopy of these documents failing which they shall not be allowed to appear in interview.
- 15. SC/ST/PwBD candidates appearing for written test will be reimbursed single second class railway fare. Please refer 6.0 (4) of notification of apprentice engagement in Indian Oil website at <u>www.iocl.com</u> under Indian Oil for Careers->Apprenticeship and at <u>https://plis.indianoilpipelines.in</u> on 31/10/2019.
- 16. Candidates who are selected as apprentices need to fulfil the medical fitness criteria and submit pre engagement Medical fitness certificate at the time of document verification which is a pre-requisite condition as mentioned in the notification. Only those candidates, whose documents as well as pre-engagement medical fitness certificate are found in order, shall be issued offer of engagement as Apprentices.
- 17. The decision of the Management in all matters relating to eligibility, acceptance or rejection of the application, mode of selection etc. will be final and no enquiry will be entertained in this regard.
- 18. Candidates are advised to visit IOCL website i.e. <u>www.iocl.com</u> and <u>https://plis.indianoilpipelines.in</u> from time to time for results of Written test and any other information.
- 19. The syllabi of notified trades to be covered during the apprenticeship training of one year are available at portal <u>https://plis.indianoilpipelines.in</u> under download section.
- 20. In case of any discrepancy between Hindi and English version of admit card, the English version will prevail.

Candidates are advised that if they are unable to Print the Admit Card from the Apprentices Portal <u>https://plis.indianoilpipelines.in</u>, they may report to the Examination centres as mentioned above against their respective Post Code, as per timings given above, with a Print Out of this Notice, along with a Photo ID Proof and 2 coloured passport size photograph as submitted online in the Portal at the time of submission of application.
