Important Notes for the candidates

1. The candidates have to ensure that they fulfil each of the eligibility criteria/parameters including qualification (along with minimum % marks in aggregate), age stipulated in our published advertisement no. PDR/HR/01/Apprentices-22 and hosted on our website www.iocl.com. In case they are not meeting the above criteria {including minimum % marks in aggregate as mentioned in Clause A (1) of aforesaid advertisement} as on the date of reckoning, they are directed not to appear for the Document Verification.
2. In case during subsequent verification of certificates / testimonials (including mark sheets), contradiction to the claim in the on-line application or any time thereafter is found, the candidature will be summarily rejected at any stage of selection process without any further notice.
3. The Roll Nos. mentioned above are not in order of merit.
4. Shortlisting of the candidates for the Document Verification does not confer any right for engagement as Apprentices.
5. Candidates shall be required to carry a copy of the online application submitted by him/her, Call letter issued for written test, 5 nos. recent Pass port size Color photograph along with **the originals** & self-attested copies of all testimonials for verification as mentioned below:
 - a. 10th Pass/Matriculation certificate issued by the concerned education board as proof of date of birth.
 - b. Class XII mark sheet issued by the concerned board/ Semester-wise/ year-wise mark sheets of ITI (Fitter) issued by NCVT or SCVT/Graduation/Diploma Engineering
 - c. Class XII/Final ITI (Fitter) issued by NCVT or SCVT/Graduation/Diploma Certificate issued by respective Board/ Authority
 - d. Conversion certificate from CGPA/OGPA/Letter Grade to percentage of marks, if applicable, from concerned University/Institute.
 - e. Certificate mentioning the date of publication of result from the Principal of the Polytechnic/ School/College/ Institute from where the candidate pursued his/her Class XII/ITI (Fitter)/ Graduation/ Diploma course, if applicable.
 - f. SC/ST/Disability Certificate/ OBC (NCL) Certificate along with "Declaration"/ EWS-Income & Asset Certificate/ "DECLARATION" for ECONOMICALLY WEAKER SECTIONS candidates. Certificate must be in the prescribed format (available on websites www.iocl.com and www.iocrefrecruit.in) and issued by Competent Authority.
 - g. For Candidates applying against Code 111 with Skill Certificate in 'Domestic Data Entry Operator' - Skill certificate issued by an awarding body recognised under National Skill Qualifications Framework or any other authority recognised by the Central Govt. in this regard.
 - h. The candidates are advised to bring proof of regular / full-time course for Class XII/Graduation / Diploma qualification.
 - i. Any other Certificate, as specified.

6. The candidature of the applicant would be provisional and subject to subsequent verification of certificates/ testimonials etc. At any stage of the selection process, if it is found that the candidate has furnished false or incorrect information, the candidature of the candidate will be cancelled.
7. Only those communities that are mentioned in the common list of OBCs approved by Central Government shall be treated as OBC for the purpose of reservation.
8. Outstation SC/ST/PwBD candidates will be eligible for reimbursement of 2nd class Rail/Ordinary bus fare to and fro by the shortest route between the place of mailing address or actual place of journey and the place of Document Verification, whichever is less, subject to submission of TA claim form with rail tickets /bus tickets and a copy of caste certificate in the format prescribed. 9. Candidates are advised to plan for stay of 2-3 days at Paradip for document verification and subsequent Pre Engagement Medical Examination. Corporation does not hold any responsibility for the same.
10. Candidates are advised to carry sufficient money with them as some of the Medical tests may be carried out, outside the Hospital, in case the facility is not available at our Hospital.
