#### **INSTRUCTIONS TO THE SHORTLISTED CANDIDATES:**

- The Roll Nos. mentioned above are not in order of merit.
- Shortlisting of the candidates for the Document Verification does not confer any right for engagement as apprentices.
- Candidates are advised to bring all original certificates / Mark Sheets along with one set of 10th, 12th, ITI
  Course, Skill Certificate in "Domestic Data Entry Operator" / Diploma / Degree course (as applicable) for the
  relevant Codes, proof of date of birth, Caste/Tribe Certificate, certificate proving EWS status (as applicable),
  Disability certificate (as applicable), along with one set of photocopies and passport size photographs (five
  nos.) failing which they will not be allowed to appear in the Document Verification.
- Only those communities that are mentioned in the common list of OBCs approved by Central Government shall be treated as OBC for the purpose of reservation.
- The candidature of EWS candidate is liable to be cancelled, if at the time of joining, the candidate is not able to produce the requisite certificate/(s) proving his/her EWS status.
- Outstation SC/ST/PwBD candidates will be eligible for reimbursement of IInd class Rail/Ordinary bus fare to
  and fro by the shortest route between the place of mailing address or actual place of journey and the place of
  Document Verification, whichever is less, subject to submission of TA claim form with rail tickets/bus tickets
  and a copy of caste/PwBD certificate in the format prescribed (TA Claim format can be downloaded from the
  website <a href="https://www.iocl.com">www.iocl.com</a>), provided the distance is not less than 30 Kms.
- Candidates, whose documents are found to be in order, shall be advised to undergo Pre-Engagement Medical Examination at IOCL-VK Hospital, Paradip Refinery Township, Paradip, Odisha 754141, the schedule of which shall be subsequently communicated to the candidates. Accordingly, candidates are requested to carry sufficient money with them for their stay, travel and medical tests as some of the tests are carried out in other Hospitals, as the facility is not available at our Hospital. The expenses incurred for Pre-engagement Medical examination shall only be reimbursed. Candidate has to bear the expenses in connection with their stay and travel.
- The candidature of the applicant would be provisional and subject to subsequent verification of certificates and testimonials etc. In case it is detected at any stage of engagement or thereafter, that a candidate does not fulfill the eligibility norms (Refer detailed Advertisement No. PDR/HR/02/Apprentices-19). and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled.
