- 16. For Discipline Code 78/79/80/81/82/83/84/85/86: PwBD candidates with less than 40% of permanent disability are NOT eligible. The PwBD candidates are required to submit a Disability Certificate issued by Competent Authority as per the Persons with Disabilities (equal opportunities, Protection of Rights and Full Participation) Amended Rules, 2009, failing which their candidature as PwBD candidates will not be considered. Persons with Disabilities must be capable of performing the task assigned to them/take instructions using suitable aids and appliances.
- 17. The candidates who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in an Industry as per the Apprenticeship Act, 1961/1973 as amended from time to time or job experience for a period of 1 year or more are NOT eligible.
- 18. Applicants who have completed 3 YEARS after acquiring the prescribed qualification for engagement of TECHNICIAN APPRENTICE i.e, Diploma in Engineering in the relevant discipline shall NOT BE ELIGIBLE for engagement as Technician Apprentice.
- 19. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the Polytechnic/College/Institute from where the candidate pursued his ITI course/Graduation/Diploma in Engineering, along with his application form.
- 20. Candidates registered with Local / State Employment Exchange(s) / Vocational Rehabilitation Centre for Person with Benchmark Disability (PwBD) and meeting the prescribed eligibility criteria, are required to <u>apply Online, failing which their candidature will not be</u> <u>considered</u>.
- 21. Candidates with qualification acquired through Distance Learning Mode or Part Time Mode or Correspondence mode shall **NOT** be considered.
- 22. Candidates possessing higher professional qualifications such as **B.E or equivalent**, **MBA or equivalent or MCA / CA/ ICWA**, **LLB shall NOT** be considered. Suppression of information regarding possession or pursuing higher qualification shall render a candidate ineligible for consideration at any stage of selection/termination or any time during engagement.

B. Age: Minimum 18 years and maximum 24 years as on **31.01.2018** (Relaxable by 5 years for SC/ST i.e. up to a max of 29 yrs., 3 years for OBC i.e. up to a max of 27 yrs., for the posts reserved for them).

Candidates belonging to PwBD categories shall be given age relaxation up to 10 years (up to 15 years for SC/ST and up to 13 years for OBC (Non-Creamy layer) candidates.

D. Selection Methodology:

- 1. The Selection process would consist of two stages i.e. written test. The Written Test will comprise of 100 questions and shall be of **90** minutes duration & would mainly comprise of objective type questions. The questions would be in bilingual i.e. English & Hindi. The written test would carry a weightage of 85% and the weightage for interview will be 15%.
- 2. The written test will assess the candidates on the following parameters:-

The candidates will have to qualify successfully through each stage of the selection process i.e. Written Test and Personal Interview (Minimum 40%, relaxable by 5% for candidates from SC/ST/PwBD categories against reserved positions) and Pre-employment medical fitness for being adjudged suitable for engagement.
- 4. Candidates are advised to ensure that they are medically fit as per Indian Oil's pre-employment medical standard.
