    Institute from where the candidate pursued his/her Class XII/ITI (Fitter)/ Graduation/ Diploma course, if
    applicable. Certificate from the Principal of the Polytechnic/ School/College/ Institute from where the candidate
    pursued his/her Class XII/ITI (Fitter)/ Graduation/ Diploma course must also mention that course was

- 6. Original photo ID proof (AADHAAR/ PAN/ Driving License/ Voter Identity Card/Passport) along with self-attested copy of the same.
- 7. Candidates found meeting the eligibility criteria will be advised to report for Pre-Engagement Medical Examination (PEME) after completion of documents verification.
