- i) Skill/Proficiency/Physical Test (SPPT) for the post of Junior Attendant (Grade I).
- ii) Computer Proficiency Test (CPT) for the post of Junior Business Assistant (Grade III).

It may be noted that only those candidates whose documents are prima facie found to be in order during document verification, shall be allowed to appear on the same day for Skill/Proficiency/ Physical Test (SPPT)/ Computer Proficiency Test (CPT), which is qualifying in nature. However, only those candidates, who are found FIT by the Committee in SPPT/CPT, shall be considered for inclusion in Final Merit List based on their marks in the Computer Based Test (CBT).
