c)	Self-attested copies of the following documents:
i)	Matriculation certificate issued by Board of Secondary Education. In case Date of Birth (DOB) is not mentioned on the Matriculation Certificate by the concerned Education Board, School Leaving Certificate / Admit Card /Matriculation mark sheet mentioning DOB shall be additionally required to be submitted along with the Matriculation Certificate.
ii)	Marksheet of Class XII by the concerned education Board / Semester-wise or year-wise mark sheets of Graduation/Diploma in Engineering issued by University/ Institute (as applicable)
iii)	Certificate of Class XII Pass by the concerned education Board / Graduation/Diploma in Engineering Final/ Provisional Pass Certificate issued by respective University/Institute (as applicable)
