SC & PwBD candidates appearing for SPPT will be reimbursed single second class rail fare from nearest railway station from the mailing address to the place of SPPT (if shortlisted) and back by the shortest route on production of ticket and copy of cancelled cheque or Pass book, provided the distance is not less than 30 Kms.
