The venue for Document Verification is as under:

VENUE: Indian Oil Corporation Limited, Southern Region Pipelines, House of Four Frames, 6/13, WheatCroft Road, Nungambakkam, Chennai 600034.

Only those candidates, whose documents are found in order, shall be allowed to appear for Skill/Proficiency/Physical Test (SPPT) which shall be qualifying in nature only. However, only those candidates, who are found FIT by the Committee in SPPT, shall only be considered for inclusion in Final Merit list cum selection list based on their marks in the Written Test. The details of selection process for SPPT is already mentioned in our website notification dated 29.08.2019.

DOCUMENTS REQUIRED FOR VERIFICATION

The following original documents along with a self attested copies are required to be furnished at the time of SPPT:

- 10th pass/ Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- Caste (SC/ST/OBC) / Tribe / Disability certificate issued by the Competent Authority.
- Semester-wise / year-wise mark sheets and Certificate of Full-time ITI / Diploma in Engineering in respective Discipline, Trade Certificate/National Trade Certificate issued by SCVT/NCVT in respective trades.
- Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma/ Degree/ITI examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by University/ Institute. The supporting document should also be produced at the time of SPPT in case the candidate gets shortlisted for SPPT.

- v) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization.
- vi) One Passport size color Photograph
- vii) Any other Certificate, if applicable

IMPORTANT

1. **Without original documents, candidates shall not be allowed to appear in SPPT.**
2. After checking, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself shall be responsible for safe custody of original documents.
3. During document verification before the SPPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
4. The information furnished by the candidate in the online portal with regard to qualification, age, category etc. shall be cross-checked from the original documents of the candidates.
5. Please note that during subsequent verification of documents, in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process without any further notice to you.
6. Please ensure that you fulfill all the eligibility criteria as stipulated in our detailed Advertisement No. PL/HR/ESTB/RECT-2019 (1) dated 29.08.2019, hoisted on our website www.iocl.com and <https://plis.indianoilpipelines.in>

Candidates who are pursuing higher qualification on the date of final submission of online application but have acquired/completed the same subsequently at the time of Skill/Proficiency/Physical Test (SPPT), shall not be eligible for selection and shall not be allowed to appear for SPPT.
