All the shortlisted candidates are advised to appear for SPPT only if they are meeting all the prescribed criteria for eligibility and if they are in possession of originals of all the documents related to their Date of Birth; Educational Qualification; latest Caste Certificate (for SC/OBC-NCL), as applicable, in the prescribed proforma; No Objection Certificate of employer, as applicable; In case of Apprenticeship: Completion certificate from BOAT/BOPT/RDAT/NCVT and any other document as required in our detailed advertisement. Or otherwise relevant with respect to various criteria mentioned in our detailed advertisement for submission.

- Candidates provisionally shortlisted for SPPT are advised to come along with All the Original certificate/ documents along with one self of SELF-ATTESTED photocopies of all the documents that have been prescribed in the Checklist enclosed herewith as **Annexure A**.
- The candidates are also required to fill and submit the “**Document Submission Checklist**” (**Annexure A**) at the time of SPPT. All candidates are advised to CAREFULLY go through the list of documents at Annexure A and the advertisement so as to come prepared for verification of all the documents and originals. Apart from the specified documents, candidates may submit any relevant documents with respect to various criteria mentioned in our detailed Advertisement.

**NOTE:**

- ✚ The candidature **shall be considered** for the candidates **who appropriately submit all the prescribed documents along with production of the Original documents/ certificates.**
- ✚ **Also, only the documents submitted by the candidate shall be taken into consideration for checking and basing the eligibility of the candidate.**
- ✚ **Candidates submitting incomplete documents will be liable for rejection.**
- ✚ It may be noted that mere submission of documents does not entitle the candidate for appointment/selection. Candidature of candidates is liable for Rejection at any stage of selection or for Termination during the process and even after appointment; in case anything contrary to their declaration/submission is found at a later stage.

<b>1</b>	Signed Print-out of Online application form and copy of call letter / admit card issued.
<b>2</b>	<b>Proof of Date of Birth:</b> Certificate issued by a Board of Secondary Education for passing Matriculation/Higher Secondary shall be the only acceptable document in support of proof of age.
<b>3</b>	Passport size photograph
<b>4</b>	Xth Pass & XIIth Pass Certificate and Mark Sheet issued by the respective Board/University
<b>5</b>	Diploma / BSc (PCM): Final / Provisional Pass Certificate issued by the respective Board/University/ as applicable.
<b>6</b>	All the Mark Sheet (Semesters/Year wise) of Diploma/B.Sc. (PCM) issued by the respective Board/University.
<b>7</b>	Proficiency certificate from BOAT/BOPT or SCVT/NCVT in case of Apprentices
<b>8</b>	Certificate from the Institute where the candidate has pursued his Degree/Diploma/Sandwich Diploma (Industrial Training as a part of course with no break) course indicating that course is a regular full time course and the date of publication of result of the final year/ final semester of the Degree / Diploma course in case the date of Declaration of result is not mentioned in the Mark Sheet/Certificate.
<b>9</b>	Copy of documents related to higher qualification being pursued ( suppression of any information regarding possession or pursuing of any higher qualification shall render a candidate ineligible for consideration at any stage of selection and termination from services, in case recruited)
<b>10</b>	Proof of Qualification ( equivalence) and Service Certificate/ Discharge Certificate etc in case of Ex-Servicemen
<b>11</b>	Experience Certificate or Copy of Offer Letter, Joining Letter, Payslips, Increment Letter, relieving letter etc. Proving the continuance in service for the claimed period as experience.
<b>12</b>	'No Objection Certificate' from the employer in case employed with Government/ Semi Government/ PSU Bodies
<b>13</b>	Copy of SC/OBC (NCL) certificate in the prescribed format (mentioning applying for appointment to post under the Government of India)
<b>14</b>	Copy of Photo Identity Proof ( Driving License/ Voter Id/ PAN Card/ Passport etc)
<b>15</b>	Aadhaar Card
<b>16</b>	Self Declaration on Medical fitness: Documents with reason for being declared UNFIT earlier in case of Medical Examination conducted by any Refinery and Declaration of any ailments, deficiencies or abnormalities, or findings of not meeting the physical fitness criteria as per Indian Oil's Pre-Employment medical standards.
