- Candidates must submit a copy of Experience Certificates (s), Apprenticeship Completion Certificate issued by previous employer(s) or copy of Appointment Letter and Last Pay slip, (Copy of Work Order and Proof of working in Large Industrial Establishment, as applicable) are also required to be produced as a proof of the requisite post qualification experience as per our advt.
