

COPS MAY INVOKE UAPA IN BAJRANG DAL WORKER'S MURDER CASE

BENGALURU: Karnataka police have invoked provisions of the stringent Unlawful Activities (Prevention) Act (UAPA) against the 10 people accused in the murder of Bajrang dal activist Harsha Jinge, 26, two senior officers familiar with the probe said on Monday. "We have put UAPA on them," said the first official, requesting anonymity.

Harsha was stabbed on February 20 in Bharti Nagar locality of Shivamogga. The second official cited above said that the murder was committed in a way to instil fear in society, which warrants the stringent sections of the law.

BJP MP from Udipi-Chikmagalur and union minister of state for agriculture and farmers welfare Shobha Karandlaje had indicated on Saturday that the case could be handed over to the central agency within a week. Police have named 10 people, all Muslims, as accused. "There is no requirement for organised crime to take place (for UAPA to be invoked). If there is a crime, that is brutal enough, you can book the accused under UAPA," said a third official. **HTC**

An all-women bench to hear proceedings in Kerala HC for first time

NEW DELHI: A bench comprising only women judges will hear a case in the Kerala high court on Tuesday, states a report by online portal LiveLaw. This is the first time in the history of the Kerala high court that a full bench comprising only women judges has been constituted. Incidentally, the day coincides with the International Women's Day.

The cause list shows justices Anu Sivaraman, V Shircy and M R Anitha as members of the women's only full bench. The full bench will be adjudicating upon a review petition filed by the state government seeking reconsideration of the previous order of another full bench quashing the contribution of the Guruvayur Devaswom Fund to the Government's Disaster Relief Fund.

In 2020, a full bench comprising justices A Hariprasad, Anu Sivaraman and MR Anitha had

held that the Guruvayur Devaswom Managing Committee has no authority to contribute from the Devaswom Funds to Chief Minister's Distress Relief Fund or to any other governmental agency.

The court had then observed that all the properties, including movable and immovable properties and money, dedicated to or endowed in the name of Lord Guruvayurappan or any property acquired in any manner by Guruvayur Devaswom will vest in the idol of Lord Guruvayurappan, consecrated in Sree Krishna temple.

The court was answering a reference from the division bench if the Guruvayur Temple managing committee can make donations for non-religious purposes, before the chief justice for consideration by a larger bench. Justice Shircy was reinstated following the retirement of justice Hariprasad, who was earlier a member of the full bench which considered the petition.

{ IRDA REPORT }

UNPAID CLAIMS FOR NATURAL DISASTERS AT OVER ₹1,705 CR

NEW DELHI: Insurance Regulatory and Development Authority of India's annual report says that outstanding claims for natural disasters in 2020 and 2021 amount to ₹1,705.52 crore. These include insurance claims for super cyclone, Amphan; severe cyclone, Nisarga; very severe cyclone Nivar; floods in Maharashtra, Telangana, Andhra Pradesh, and other states.

As per the report, total claims for natural disasters during the period were worth ₹2,559.10 crore, of which 29.72% claims worth ₹760.68 crore were settled. "In case of a major calamities, IRDAI issues instructions to insurers to expedite the processes for receiving, verifying and settling claims, and simplify documentation. Disposal is monitored daily by the head office of the insurers and weekly by IRDAI. Majority of claims get settled early, a few large claims remain pending as insurers have to wait for the process to be completed to assess the amount," said Subhash Chandra Khuntia, former chairperson of IRDAI. **HTC**
