All the shortlisted candidates are advised to appear for SPPT only if they are meeting all the prescribed criteria for eligibility and if they are in possession of originals of all the documents related to their Date of Birth; Educational Qualification; latest Caste Certificate (for SC/ST/OBC/EWS), as applicable, in the prescribed proforma; No Objection Certificate of employer, as applicable; In case of Apprenticeship: Completion certificate from BOAT/BOPT/RDAT/NCVT and any other document as required in our detailed advertisement. Or otherwise relevant with respect to various criteria mentioned in our detailed advertisement for submission.

- The candidates are also required to fill and submit the “**Document Submission Checklist**” (**Annexure A**) at the time of SPPT. All candidates are advised to CAREFULLY go through the list of documents at Annexure A and the advertisement so as to come prepared for verification of all the documents and originals. Apart from the specified documents, candidates may submit any relevant documents with respect to various criteria mentioned in our detailed Advertisement.
- Candidates are advised to mandatorily follow all Covid-19 related guidelines i.e wearing face mask, carrying their own sanitizer and maintaining social distancing, etc.

NOTE:

- ✚ The candidature **shall be considered** for the candidates **who appropriately submit all the prescribed documents along with production of the Original documents/ certificates.**
- ✚ **Also, only the documents submitted by the candidate shall be taken into consideration for checking and basing the eligibility of the candidate.**
