Only those candidates, whose documents are found in order, shall be allowed to appear for Skill/Proficiency/Physical Test (SPPT) which shall be qualifying in nature only. However, only those candidates, who are found FIT by the Committee in SPPT, shall be considered for inclusion in Final Merit List based on their marks in the Computer Based Test (CBT). DOCUMENTS REQUIRED FOR VERIFICATION

The following original documents along with self-attested copies are required to be furnished at the time of Document Verification:

10th Pass / Matriculation Certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.

Caste (SC/ST/OBC)/EWS/Disability Certificate of reserved category candidates in the prescribed format issued ii) by the Competent Authority.

For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the format prescribed by Govt. of India, which would, among others specifically mention that the candidate does not belong iii) to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt.(SCT) dated 08.09.1993 & OM No. 36033/1/2013-Estt.(Res.) dated 13.09.2017 and other guidelines issued from time to time. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Further, name of OBC caste mentioned in the certificate should fall in the central list of OBCs of the respective State and non-creamy layer status should be valid as on 20-07-2024.

v) Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma/ITI examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by the University/Institute. The supporting document should also be produced at the time of SPPT in case the candidate gets shortlisted for SPPT.
