The short-listed candidates are advised to appear for Document Verification on the date, time and venue, as mentioned above.

Only those candidates whose documents are found in order shall be allowed to appear for Skill Proficiency Physical Test (SPPT) which shall be qualifying in nature only. However, only those candidates, who are found FIT by the Committee in SPPT, shall only be considered for inclusion in Final Merit list-cum-Selection list based on their marks in the Written Test. The details of selection process for SPPT is already mentioned in our website notification dated 07.08.2018.

## DOCUMENTS REQUIRED FOR VERIFICATION

The following original documents along with self-attested copies are required to be furnished at the time of SPPT:

- 10<sup>th</sup> pass/ Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- ii) Caste (SC/ST/OBC) / Tribe / Disability certificate of reserved category candidates in the prescribed format issued by the Competent Authority.
- For claiming the benefit of OBC category, the candidate should submit a latest OBC certificate in the proforma prescribed by Govt. of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93- Estt.(SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Further, name of OBC caste mentioned in the certificate should fall in the Central list of OBCs of the respective state and non creamy layer status should be valid as on 07.08.2018.
- iv) Semester-wise / year-wise mark sheets and Final Certificate of 10<sup>th</sup>, 12<sup>th</sup> & Full-time Diploma in Engineering in respective Discipline.

- Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma degree examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by University/ Institute. The supporting document should also be produced at the time of SPPT in case the candidate gets shortlisted for SPPT.
- vi) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization.
- vii) One Passport size colour Photograph (preferably matching with the one used in application form)
- viii) For the purpose of this recruitment exercise, only those Persons with benchmark Disabilities as mentioned against the respective post codes in the Website Notification dated 07.08.2018, who are having **minimum 40% disability** shall be considered as a PwBD candidate. Relaxations/concessions as provided by the Rights of Persons with Disabilities Act 2016 shall be duly admissible.

### Please note the following:

PwBD candidates only with the following specified disabilities shall be considered in terms of clause (zc) of section 2 of the Rights of Persons with Disabilities Act, 2016, for the respective notified post:

- "Leprosy Cured Person" means a person who has been cured of leprosy but is suffering from:
  - (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
  - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
  - (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly.
- "Dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less.
- "Acid Attack Victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.
- PwBD candidates having disabilities other than the above, need not to come for further selection process and their candidature shall not be considered for the notified post.
- ix) Any other Certificate, if applicable

#### **IMPORTANT**

- 1. Without original documents, candidates shall not be allowed to appear in SPPT.
- 2. After checking, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself shall be responsible for safe custody of original documents.
- 3. During document verification before the SPPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
- The information furnished by the candidate in the online portal with regard to qualification, age, category etc. shall be cross-checked from the original documents of the candidates.
- 5. Please note that during subsequent verification of documents; in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process or later without any further notice to you.
- 6. Candidates who are pursuing higher qualification on the date of final submission of online application but have acquired/completed the same subsequently at the time of SPPT, shall not be eligible for selection and shall not be allowed to appear for SPPT. - 8. Candidates who do not meet any of the criteria need not appear for document verification / SPPT.
- 9. Candidates called for SPPT shall be required to come prepared and make their own arrangement for stay.

- 11. Candidate to please note that appearing for SPPT does not confer an offer of employment to him/her. His/her candidature for this test is provisional and is subject to his/her fulfilling the educational and other eligibility criteria prescribed for the post.
