The short-listed candidates are advised to appear for Document Verification on the date, time and venue, as mentioned against their names in the attached Annexures.

The venue for Document Verification is as under:

**VENUE: Eastern Region Pipelines, Mourigram Headquater, PO- Duilya, Andul-Mouri, Mourigram, Howrah-711302 (West Bengal) (Near Mourigram Railway Station)**

Only those candidates, whose documents are found in order, shall be allowed to appear for Skill/Proficiency/Physical Test (SPPT) which shall be qualifying in nature only. However, only those candidates, who are found FIT by the Committee in SPPT, shall only be considered for inclusion in Final Merit list cum selection list based on their marks in the Written Test. The details of selection process for SPPT is already mentioned in our website notification dated 12.09.2022.

**DOCUMENTS REQUIRED FOR VERIFICATION**

The following original documents along with a self attested copies are required to be furnished at the time of SPPT:

- 10<sup>th</sup> pass/ Matriculation certificate issued by the concerned education board as proof of Date of Birth. No other document will be accepted for verification of Date of Birth.
- Caste (SC/ST/OBC) / Tribe / Disability certificate of reserved category candidates in the prescribed format issued by the Competent Authority.
- For claiming the benefit of OBC category, the candidate should submit a latest OBC certificate in the proforma prescribed by Govt. of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93- Estt.(SCT) dated 08.09.1993.



Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Further, name of OBC caste mentioned in the certificate should fall in the central list of OBCs of the respective State and non-creamy layer status should be valid as on 12.09.2022.

- iv) Semester-wise / year-wise mark sheets and Certificate of Full-time ITI / Diploma in Engineering in respective Discipline.
- v) Wherever CGPA/OGPA or Letter Grade is awarded in the Diploma/ Degree/ITI examination, its equivalent aggregate percentage of marks must be indicated in the Online Application Form as per the norms adopted by University/ Institute. The supporting document should also be produced at the time of SPPT in case the candidate gets shortlisted for SPPT.
- vi) Valid discharge Certificate for Ex-servicemen candidates.
- vii) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization.
- viii) One Passport size colour Photograph
- ix) **Persons with benchmark Disabilities having only the disabilities of Leprosy Cured/Acid Attack Victims/Dwarfism with minimum 40% disability shall be considered as a PwBD candidate as per the Rights of Persons with Disabilities Act 2016, for the posts notified above, and the applicable relaxations/concessions shall be available to them.**
- x) Any other Certificate, if applicable

#### IMPORTANT

1. **Without original documents, candidates shall not be allowed to appear in SPPT.**
2. After checking, original documents shall be returned to the candidates on the same day and only the self-attested copies shall be retained by IOCL. Candidate himself shall be responsible for safe custody of original documents.
3. During document verification before the SPPT or at any stage of selection process, in case it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/doctored/false information/certificate/documents or has suppressed any material fact(s) or is unable to produce original documents or possesses higher qualification, his/her candidature will stand cancelled.
4. The information furnished by the candidate in the online portal with regard to qualification, age, category etc. shall be cross-checked from the original documents of the candidates.
5. Please note that during subsequent verification of documents, in case the revelation is contrary to your claim, your candidature will be summarily rejected at any stage of the selection process without any further notice to you.
6. Please ensure that you fulfill all the eligibility criteria as stipulated in our detailed Advertisement No. PL/HR/ESTB/RECT/2022(2) dated 12.09.2022, hoisted on our website [www.iocl.com](http://www.iocl.com) and <https://plapps.indianoil.in>

11. Candidate to please note that appearing for SPPT does not confer an offer of employment to him/her. His/her candidature for this test is provisional and is subject to his/her


fulfilling the educational and other eligibility criteria prescribed for the post. Mere attending the SPPT does not guarantee employment in the Corporation.
