For Post Code–202: Junior Engineering Assistant IV (P&U): At the time of SPPT, candidates possessing a National Apprenticeship Certificate (NAC) in Boiler Attendant under the Apprentices Act, 1961 must **MANDATORILY** produce NAC with due endorsement of equivalence to the 2nd class Boiler Attendant Certificate of Competency by the competent Boiler Authority of the State of Assam.
