Applications are invited from Indian Nationals fulfilling the following eligibility criteria for admission to the GNM course for the session 2024-25 at Assam Oil School of Nursing at IOCL (AOD), Digboi Refinery. Only **female candidates** meeting the following criteria may apply.

06 (six) no. seats shall be reserved for candidates belonging to Digboi Legislative Constituency (DLC), candidates claiming reservations shall be required to produce valid supporting document.

COURSE DETAILS:

• General Nursing & Midwifery Course (GNM) course will be a full-time regular course for a duration of 3 (three) years.

<u>MODE OF ADMISSION & RECOGNITION:</u> The students of GNM will be admitted to Assam Oil School of Nursing (AOSN), which is recognized by Indian Nursing Council and the course is recognized by Indian Nursing Council.

1) Minimum Educational Qualification:

Selection process: Only female candidates are eligible for admission. Candidates shall have to apply online with GNM Entrance Examination (GNMEE-2024) Roll No. and with total marks obtained in GNMEE-2024. The candidates will have to upload the following documents in our AOSN online portal.

- a) 10+2 class passed preferably Science (PCB) & English with aggregate of 40% marks at the qualifying examination from a recognized Board.
- b) Candidates are also eligible from state open school recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government.
- c) 10+ 2 in Arts (Mathematics, Biotechnology, Economics, Political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, Philosophy) and English Core/English Elective or Health care Science Vocational stream ONLY, passing out from recognized Board under AISSCE/CBSE/ICSE/SSCE/HSCE or other equivalent Board with 40% marks.
- d) 10+2 vocational ANM under CBSE Board or other equivalent Board from the school and recognized by Indian Nursing Council with 40% marks.
- e) Registered as ANM with pass marks from State Nursing Registration Council.
- f) Class X & XII marksheet and certificate issued by the concerned board.
- g) Conversion certificate from CGPA/OGPA/Letter Grade to percentage of marks, if applicable, from concerned board.
- h) Income Certificate (FY 2023-24) issued by Competent Authority. Issued on or after 01.04.2024.
- i) Candidates seeking reservations under Digboi Legislative Constituency are required to produce Voter Identity card of self or parent.
- i) GNMEE Score card 2024.

The prescribed qualification should a regular course. If a candidate fails in any of the above-mentioned subject whether it is a compulsory/additional subject, her application shall be summarily rejected. Grace marks given by the board shall not be taken into calculation for calculating pass marks.

- 2) Candidates possessing professional qualifications training/ course such as BE/ B.Tech, MBA, CA, LLB, MCA etc. or any such equivalent qualification shall not be eligible.
- 3) <u>Age Limit:</u> Minimum age for admission will be 17 years (as on <u>31.12.2024).</u> The upper age limit is 35 years. Age relaxation applicable for SC/ST/OBC candidates as per presidential directives. Certificate issued by a Board of Secondary Education for passing Matriculation (Class-X) examination shall be the only acceptable document in support of proof of age.
 - Relaxation in upper age upto 5 years for SC/ST candidates and 3 years for OBCNCL candidates considered against reserved positions will be allowed.
- 4) Filling up of seats is solely at the discretion of the management based on suitability of candidates and no claim will arise for engagement, if some of these seats are not filled due to unsuitability/insufficient in number of candidates.
- 5) The decision of the Management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection and cancellation of the selection process etc. No correspondence will be entertained in this regard.
- 6) Only those candidates who are declared fit in medical examination shall be considered for admission.
- 7) How to Apply: Candidates to apply online through the following online application link after declaration of GNMEE result. https://aocnadmission.in/
- 8) <u>Candidates are required to upload the scanned copy of the following documents on the above-mentioned Online application link</u>

Original documents along with a self –attested copy should be furnished at the time of document verification:

- 10th Pass/Matriculation certificate issued by the concerned education board as proof of date of birth. No other document will be accepted for verification of date of birth.
- SC/ST/OBC(NCL)/EWS Income & Asset Certificate by reserved category candidates in the prescribed format issued by Competent Authority.
- Class X- & XII-mark sheet and certificate issued by Competent Authority.
- Conversion certificate from CGPA/OGPA/Letter Grade to percentage of marks, if applicable, from concerned University/Institute.
- Income Certificate (FY 2023-24) (i.e issued on or after 01.04.2024) by Competent Authority.
- Candidates seeking reservations under Digboi Legislative Constituency Candidates are required to produce Voter Identity card of self or parent.
- GNMEE Score card 2024.
- Any other Certificate, as specified.
- 9) In case the above positions reserved for Digboi Legislative Constituency remains unfilled, then such unfilled position shall be filled up by any other candidate against Unreserved seats in order of merit to fulfill the capacity intake of 30 no. of seats allocated per year for GNM Course by INC.
- 10) Income Certificate: Income certificate issued by competent Revenue Authority only not below the rank of Circle Revenue Inspector/any other competent authority authorized to issue such income certificate in the state, indicating gross joint annual Income of the family of candidate from all sources. Any affidavit for income proof will not be accepted. The income certificate should be of the financial year i.e. (FY 2023-24) (i.e. issued on or after 01.04.2024)
- 11) AOSN Nursing Institutes being flagship CSR funded projects of the Corporation, preference would be given to the applicants belonging to the economically underprivileged weaker sections of society. Final merit list will be prepared based of score of GNMEE written examination and weightage marks of Income certificate.

12) Stipend & Training Details

The selected candidates shall be paid a consolidated stipend per month for 1st year – Rs. 2,500/-; 2nd year – Rs. 2,700/-; 3rd year – Rs. 2,900/-.

Additional benefits / opportunities for GNM courses:

- (1) Free hostel accommodation, medical attention for self at AOD Hospital and uniform will be provided to all selected candidates. Selected candidates will be required to stay in the Nursing College hostel only.
- (2) After passing out from respective courses, the candidates will be engaged compulsory for a period of 1 (one) year as working interns at AOD Hospital or in any of the other hospital of Indian Oil Corporation Ltd. This may be extendable by maximum 2 (two) years at the sole discretion of IOCL (AOD). The working interns shall be paid a consolidated stipend of Rs. 15,250/- per month for GNM at AOD Hospital and shall be paid an additional amount of Rs. 1,000/- per month if they are placed at other hospitals of Indian Oil Corporation Limited, other than at AOD hospital. During the period while they are engaged as working interns, they shall not be provided with the accommodation facility.

13) General Instructions:

- a) Candidates are advised to carefully read the full advertisement for details of educational qualification and other eligibility criteria.
- b) SC/ST candidates appearing for written shall be reimbursed 2nd class rail/bus fare by the shortest route on production of ticket, provided the distance travelled from the mailing address to the venue of Test/counselling exceeds 60 KM both ways.
- c) For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the Performa prescribed by Govt. of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training in the Government of India OM No. 36012/22/93-Estt. (SCT) dated 8.9.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBCNCL reservation benefits. IOCL (AOD) being a Central Public Sector Undertaking, only those communities that are listed in the common list of OBC prepared by Central Government shall be treated as OBCNCL for the purpose of reservation.
- d) The candidates seeking reservations under Digboi Legislative Constituency are required to produce Voter Identity card and no other document shall be considered as support document.
- e) The decision of the Management will be final and binding on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process etc.
- f) The Corporation will have no obligation to offer regular employment.
- g) Candidates belonging to Economically Weaker Section (EWS) category are required to submit an Income & Asset Certificate issued by Competent Authority prescribed under point no 5 of the Department of Personnel & Training's O.M. No 36039/1/2019-Estt (Res) dated 31.01.2019.
- h) At any stage of the selection processes or after selection if it is found that the candidate has furnished false or incorrect information then the candidature of the candidate or selection to the above course is liable to be terminated /cancelled.
- i) Candidates must necessarily declare in case she has been arrested, prosecuted, kept under detention, or fined, convicted by a Court of Law or for any offence debarred / disqualified by any public Service Commission form appearing in its examination.
