Instructions to the candidates provisionally shortlisted for appearing in the SPPT

- The candidates should appear for the SPPT strictly as per the schedule mentioned above.
- The candidature of all the shortlisted candidates are provisional and subject to their meeting the prescribed eligibility criteria as notified vide our advertisement. In case, any of the candidates do not meet the prescribed eligibility criteria, they are requested not to appear for the SPPT.
- The candidature of any candidate is liable to be cancelled if at any stage it is found that he/she does not meet the prescribed eligibility criteria.
- Merely getting shortlisted for the SPPT does not confer any right for appointment.
- Candidates are advised to bring all **original documents** along with self -attested copies of the same at the time of Skill/Proficiency/Physical Test (SPPT), falling which they will not be allowed to appear in the SPPT:
 - 1. Two nos. of latest passport size photograph.
 - Matriculation/HSC or other relevant certificate in support of Proof of Age (PAN Card, Voter ID Card, Passport, Driving License in support of Date of Birth are not acceptable).
 - 3. Mark-sheets starting from Matric, Intermediate and Degree/Diploma/ITI all semesters/years mark sheets/certificates and Final Diploma/ITI/Degree Certificate.
 - 4. Documents pertaining to Experience (Offer of Appointment, Current Pay Slip, Experience Certificate etc.)
 - 5. Copy of the relevant page of the last published Balance sheet of the establishment indicating Large Industrial Establishment (industrial /manufacturing Units) whose investment in plant & Machineries exceed Rs 10 crores and which has been in operation for post code 103,104,105.
 - Candidates employed, directly or by or through any agency (including a contractor) by a Large Industrial Establishment will be required to furnish copy of the work order issued to the agency/contractor along with the page of the balance sheet.
 - 7. Candidates employed in Govt./Govt. Departments/PSUs/Autonomous Bodies will be required to submit 'No Objection Certificate'.
 - 8. Caste Certificate in the prescribed format.
 - 9. All other documents as mentioned in the advertisement.

Note:

- Candidates who do not meet the eligibility criteria as per Advt No. GR/P/Rectt./18, are advised not to appear for SPPT.
- It is clarified to the candidates that their candidature is PROVISIONAL and is subject
 to their meeting the prescribed eligibility criteria (Refer advt. no. GR/P/Rectt./18) and
 subsequent verification of certificates/ testimonials. At any stage, if it is found that a
 candidate has furnished false or incorrect information then his candidature is liable to
 be cancelled.
- Candidates belonging to SC/ ST/ OBC / PwBD shall be required to produce their caste / disability certificate issued by the Competent Authority specified by the Govt. of India (Ministry of Social Justice & Empowerment). The name of caste / community to which the candidate belongs must appear in the Presidential Order / Gazette Notification issued by Govt. of India.
- For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the proforma prescribed by Govt. Of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (Creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt. (SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Accordingly such candidates may choose to apply for the positions provided they meet the age criteria applicable to UR Candidates and indicate their category as 'UR'. Indian Oil Corporation Ltd. (Guwahati Refinery) being a Central Public Sector Undertaking, only those communities that are mentioned in the common list of OBC approved by Central Government shall be treated as OBC for the purpose of reservation.
- SC/ST/PwBD candidates appearing for interview will be reimbursed single second class railway fare from the nearest railway station of the mailing address to the place of test/interview and back by the shortest route on production of ticket, provided the distance is not less than 30 KMs.
