A five-judge Constitution bench headed by chief justice of India (CJI) Dhananjaya Y Chandrachud on Tuesday started hearing a clutch of peti-Chandrachud on Tuesday started hearing a dutch of petitions challenging the validity of Section 6A, which was inserted into the Clitzenship Act of 1955 in 1985 as a special provision to deal with the clitzenship of people covered under the Assam Accord — a tripartite agreement that All Assam Students' Union (AASU) signed with the Assam government of the Assam government, to preserve and protect the cultural, linguistic and social identity of Assam. "We must bear in mind that if the Parliament were to merely grant annesty to a group of illegal immigrants it would have been a different situation. 
