### Criteria:

- 1) The Pathological Centre must have valid trade license and other legal documents.
- 2) Sample collection from residence/Refinery hospital free of cost from the patient/concerned person.
- 3) All emergency tests would be performed immediately and reports would be delivered at the earliest.
- 4) Tests reports for Indoor, Outdoor and OHC would be delivered within 24 hours.
- 5) Credit facility to be provided. The Pathological Centre must collect the samples with letter issued by Refinery hospital authorizing the tests to be conducted and submit the report to the concerned person/Refinery Hospital. The Pathological Centre will provide a credit of one month from the date of raising the bill to IOCL Haldia Refinery for payment.

While submitting the EOI, the Pathological Centre shall submit all pathology tests with rates conducted by the Pathological Centre. The rates shall be valid for 01 (one) year from the date of communication send by IOCL Haldia Refinery. The Pathological Centre shall also mention the discount on the tests.

All the documents and copies must be duly signed and stamped by the Pathological Centre.
