**Age Limit :** 25 years ( relaxable by 05 years for SC candidates ) as on 31.03.2010.

**Selection Methodology :** The selection methodology will comprise of written test followed by Interview of the shortlisted candidates. Written test and interview shall be conducted at Mathura. Canvassing in any form will be considered a disqualification.

**Other Information:- (1)** Training phase consists of practical training at Mathura Refinery and related instruction training at ATI, Mumbai. On completion of Apprenticeship Training, the candidate may appear for test to be conducted by National Council and obtain a certificate of Proficiency in the trade by the National Council. **(2)** Selected candidates will be required to execute a contract of Apprenticeship, which will be registered with the Regional Directorate of Apprenticeship Training, Northern Region , Kanpur.
