### Corrigendum/Information

Further to the Advertisement No. CSR(N)/2020 dated 21/11/2020, the following may kindly be taken into consideration by the candidates appearing for written test for admission to the B.Sc (Nursing) Course and GNM Course for the session 2020 for Assam Oil College /School of Nursing at IOCL (AOD), Digboi

- A) **The written test shall be OMR (Optical Mark Recognition) based instead of online test.**
- B) **Written test shall be held at Digboi, District- Tinsukia, Assam.** Time and exact venue of the written test shall be mentioned in the call letter.
- C) The list of candidates eligible to appear for written test on 16/12/2020 shall be displayed in IOCL website- [www.iocl.com](http://www.iocl.com) on 14/12/2020.
- D) The call letter shall be sent to the candidates on 14/12/2020 in the email ID mentioned by the candidates in the application form as well as to the email ID through which scanned copies of application and documents received by IOCL, AOD Digboi Refinery from the candidate.
- E) **Candidates are requested to download their call letter and paste recent passport size photograph** in the call letter. Further, candidates are also advised to keep a copy of the call letter with them for future reference.
- F) **Candidate will be allowed to enter in the examination center only on production of call letter. The candidate name and photograph will be verified with any of the Govt. issued photo Identity proof like PAN Card, Aadhaar card, driving license etc.**
- G) Candidates are required to submit the call letter along with copy of the Identity proof at the time of written test in the examination hall.
- H) The evaluation of answer sheet will be based on OMR assessment. **Candidates are advised to strictly use Blue/Black ballpoint pen only for answering questions.**
- I) Candidates will not be allowed to bring calculators, notebooks, mobile phone, whitener etc. into the examination hall.
- J) List of selected candidates will be declared by 19/12/2020 at Welfare Centre, IOCL(AOD) (Near Gandhi Maidan), Digboi. The list of selected candidates shall also be uploaded in IOCL website- [www.iocl.com](http://www.iocl.com).
- K) The selected candidates shall be allowed to appear for Pre Engagement Medical Examination after the verification of **self-attested copies with original documents** (refer our advertisement) failing which they will not be allowed to appear for Medical examination.

The following original and self attested documents shall be produced before Pre Engagement Medical Examination.

1. 10<sup>th</sup> Pass/Matriculation certificate issued by the concerned education board as proof of date of birth. No other document will be accepted for verification of date of birth.
2. SC/ST/OBC(NCL)/Disability/EWS-Income & Asset Certificate by reserved category candidates in the prescribed format issued by Competent Authority.
3. Class X & XII marksheet and certificate issued by the concerned board.
4. Conversion certificate from CGPA/OGPA/Letter Grade to percentage of marks, if applicable, from concerned board.
5. Income Certificate (FY 2019-20) issued by Competent Authority.
6. Candidates seeking reservations under Digboi Legislative Constituency Candidates are required to produce Permanent Residence Certificate (PRC)/ Voter Identity card.
7. Any other Certificate, as specified.
