**A. Expression of Interest (EOI) is invited from Manufacturers or their authorized sales representative for empanelment as Business Counterpart for the Import of Polymers (Polyethylene & Polypropylene grades) by IndianOil**

1. IndianOil is India's largest commercial enterprise, with a sales turnover of Rs. 3,50,603 crore (US\$ 53,560 million) and profits of Rs. 10,399 crore (US\$ 1,589 million) for the year 2015-16.
