Three years Full Time Diploma in Electrical / Mechanical / Chemical / Automobile / Electronics & Communication / Electronics & Radio Communication / Instrumentation & Control / Instrumentation & Process control engineering from a Govt. recognized Institute with minimum 55% marks.

EXPERIENCE

Preferably two-years post qualification experience in relevant area. Working knowledge of computer is desirable.

PAY & PERKS

SELECTION METHODOLOGY:

- The selection methodology will comprise Written Test followed by Trade test and Personal Interview of successful candidates from Written Test. The candidates will have to pass through each stage including medical fitness successfully for being adjudged as suitable for selection.

- Filling up of vacancies is solely at the discretion of the management based on suitability of candidates and no claim will arise for appointment, if vacancies are not filled due to unsuitability / insufficient number of candidates.

GENERAL INSTRUCTIONS:

1. Candidates are advised to carefully read the full advertisement for details of eligibility criteria and relaxations before submission of application.
2. The upper age limit of 29 years as mentioned above is inclusive of upper age relaxation of 3 years for candidates from Other Backwards Class as the post is reserved for them.
3. Service is transferable to anywhere in India.
4. Candidates employed in Government/Semi government/Public Sector Organization must send their application through proper channel or produce "No Objection Certificate" at the time of appearing in the Test/Interview. In case the candidate fails to do so, his/her candidature will not be considered.
5. Candidates should apply in the prescribed format only (**Download Application Form**) along with application fee, attested copies of mark sheets, educational qualification certificates, caste certificate and a recent passport size coloured photograph affixed on the application form.
6. Incomplete applications or applications received after the last date will not be considered.
7. OBC candidates must submit their caste certificate issued by Competent Authority along with the application form, in support of their claim to avail relaxation.
8. Application of a candidate having higher qualification than the prescribed qualification shall be rejected.
9. The candidates will have the option to appear for test/interview either in Hindi or English.
