### **NOTICE FOR CLOSURE OF TRADING WINDOW UNDER INSIDER TRADING CODE**

It is hereby notified that in terms of Clause 8.1 of the “Code for prevention of Insider Trading in the securities of IndianOil” (Insider Trading Code), the “Trading Window” for dealing in securities of IndianOil would remain closed from Wednesday, 13<sup>th</sup> March 2019 (afternoon) to Thursday, 21<sup>st</sup> March 2019 for "Insiders" (i.e. Directors, Designated Employees and "Connected Persons") of IndianOil in view of consideration of 2<sup>nd</sup> Interim Dividend for the FY 2018-19 by the Board of Directors at its meeting scheduled on 19<sup>th</sup> March 2019.

During the window closure period, the Directors, Designated Employees and Connected Persons of IndianOil shall not deal in any transaction involving purchase or sale of IndianOil “Securities” either in their own name or in the name of their “immediate relative”.

Any contravention of the above would attract Penalty as per Clause 13 of the Insider Trading Code.
