- 2. Matriculation/HSC or other relevant certificate in support of Proof of Age (PAN Card, Voter ID Card, Passport, Driving License in support of DOB are not acceptable)
- 3. Mark-sheets starting from Matric, Intermediate and Degree/Diploma/ITI all semesters/years mark sheets/certificates and Final Diploma/ITI/Degree Certificate.
- 4. Documents pertaining to Experience (Offer of Appointment, Current Pay Slip, Experience Certificate etc.)
- 5. Copy of the relevant page of the last published Balance sheet of the establishment indicating Large Industrial Establishment (industrial/manufacturing Units) whose investment in plant & Machineries exceed Rs. 10 crores and which has been in operation.
- 6. Candidates employed in Govt./Govt. Departments/PSUs/Autonomous Bodies will be required to submit 'No Objection Certificate'.
- 7. Caste Certificate in the latest prescribed format.

## Note:

- Candidates who do not meet the eligibility criteria as per Advt. No. JR/02/2017, are advised not to appear for SPPT.
- 2. It is clarified to the candidates that their candidature is PROVISIONAL and is subject to their meeting the prescribed eligibility criteria (Refer advt.
