- 1. For the purpose of date of first fixture, concluded fixture by the applicant broker in the category of GP and above vessels for crude, LPG and POL only will be considered. The applicant broker must have minimum 02 years of experience as on date of the application from the date of first fixture (as described above).
- 2. The concluded fixtures should be with 3 or more different owners. Copy of self attested signed clean fixture note or Charter Party must be submitted as a proof of having done the fixture.
- 3. Applicant should submit all the relevant supporting documents as at A,B (i), B (ii),C above along with application.
- 4. The evaluation for empanelment for fresh applicant will be done only twice a year i.e. in January and July. For January Evaluation, the application received during the period July to December will be evaluated and similarly for July Evaluation, application received during the period January to June will be considered.
- 5. Cooling off period: In case the application for empanelment gets rejected for not meeting empanelment criteria, or any other reason, then the broker / applicant will be allowed to apply afresh only after the expiry of one year from the date the applicant is informed about the rejection.
