**Experience requirement:** Preferably two-years post qualification experience in relevant area.

Age limit: Between 18-31 years as on 01.03.2012

### Concessions / Relaxation:

- 1. The upper age limit of 31 years is inclusive of upper age relaxation of 5 years for ST candidates as the post is reserved for them.
- 2. Application fee of Rs. 100/- is exempted.

ST candidates called for test/interview will be reimbursed single 2nd class railway fare limited to rail fare from the nearest railway station of the mailing address to the place of test/interview and back by the shortest route, on production of bus ticket/rail ticket provided the distance is not less than 30 kms. each side.

# **Selection Methodology:**

The selection methodology will comprise of Written test / Trade test and Personal Interview of short listed candidates. The candidates will have to pass through each stage including medical fitness successfully for being adjudged as suitable for selection.

#### **General Instructions:**

- 1. Candidates are advised to carefully read the full advertisement for details of eligibility criteria before submission of application.
- 2. Service is transferable to anywhere in India.
- 3. Candidates serving in Government/ Semi Government Departments/ Public Sector Organizations / Local Bodies must send their application through proper channel or produce "No Objection Certificate" at the time of appearing in the Test/ Interview. In case, the candidate fails to submit/ produce the certificate his/her candidature will not be considered.
- 4. Candidates should apply in the prescribed format only and should attach attested copies of mark sheet, educational qualification certificates, ST certificate, experience certificate, if any, and a recent passport size colored photograph affixed on the application form.
- 5. The candidates will have the option to appear for test/interview either in Hindi or English.
- 6. The vacancy mentioned above are likely vacancy which may increase or decrease.
- 7. Incomplete applications or applications received after the due date will be rejected.
- 8. The decision of the Management in all matters relating to eligibility, acceptance or rejection of the application, mode of selection will be final and Management will not entertain any enquiry or correspondence in this regard.
- 9. Application of a candidate having higher qualification than the prescribed qualification shall be rejected.
