- 'qualifying nature' only. Every candidate will have to secure a minimum of 40% marks at each stage for qualifying selection process. The minimum qualifying marks will be relaxed by 5% for candidates belonging to SC/ ST/ PWD categories against reserved positions.

OPPORTUNITY TO APPRENTICES:

The period of Apprenticeship Training in the relevant trade under the Apprenticeship Act of 1961 & Apprenticeship

The apprenticeship period will also be considered for grant of age relaxation; however, in such cases no further age relaxation shall be granted on account of experience.
