- ii) SC/ST/OBC certificates of reserved category candidates in the prescribed format issued by the Competent Authority. Further, OBC Non-creamy layer status should be valid as on 27.4.2017 and date of issuance of OBC certificate should be on or after 27.04.2016. - iii) Semester-wise / year-wise mark sheets and Certificate of full-time ITI / Diploma in Engineering in respective Discipline
- iv) Valid discharge Certificate for Ex-servicemen candidates
- v) No Objection Certificate, in case of candidates employed in Government / Semi Government / Public Sector Organization
- vi) One Passport size colour Photograph
- vii) Any other Certificate, if applicable

## **IMPORTANT**
