Instructions to the candidates provisionally shortlisted for appearing in the Personal Interview

- The candidates should appear for the Personal Interview strictly as per the schedule mentioned above.
- The candidature of all the shortlisted candidates are provisional and subject to their meeting the prescribed eligibility criteria as notified vide our advertisement. In case, any of the candidates do not meet the prescribed eligibility criteria, they are requested not to appear for the Personal Interview.
- The candidature of any candidate is liable to be cancelled if at any stage it is found that he/she does not meet the prescribed eligibility criteria.
- Merely getting shortlisted for the Personal Interview does not confer any right for engagement.
- All Original certificates and printout of online application is compulsorily required to be brought at the time of Personal Interview for verification. In the event of failure to produce the printout with attachments prescribed at the time of personal interview, candidature shall be treated as "Rejected".
- All the above shortlisted candidates are advised to bring the original and one set of self attested photocopies of the following documents related to their age/ qualification/ caste (if Applicable) and 2 (Two) copies of colour passport size photographs at the time of personal interview, failing which their candidature is liable to be cancelled.
 - a) Mark sheet and passing certificate of class X (As proof of date of birth).
 - b) Mark sheet of all semester/years of ITI/Diploma/Degree (Qualifying Examination).
 - c) Passing/ Final certificate of Qualification Examination ITI/ Diploma/ Degree clearly mentioning the date of completion of the course.
 - e) Original Tickets (With a set of Photocopies) for claiming Traveling allowance for To and Fro journey (Applicable for SC/ST/PwBD candidates) as per rule.
 - f) Original photo ID like AADHAAR / PAN / Driving License/ Voter Identity Card etc. (With a set of Photocopies) as a proof of identity of the candidate.
 - g) Any other relevant document that may be required to ensure eligibility/ for verification of credentials may also be brought by the candidate.
- Candidates belonging to SC/ ST/ OBC / PwBD shall be required to produce their caste / disability certificate issued by the Competent Authority specified by the Govt. of India (Ministry of Social Justice & Empowerment). The name of caste / community to which the candidate belongs must appear in the Presidential Order / Gazette Notification issued by Govt. of India.
- For claiming the benefit of OBC category, the candidate should submit a latest caste certificate in the proforma prescribed by Govt. Of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (Creamy layer) as mentioned in column 3 of the schedule to the Department of Personnel & Training, Government of India OM No. 36012/22/93-Estt. (SCT) dated 08.09.1993. Candidates belonging to OBC category but falling in creamy layer are not entitled to OBC reservation benefits. Accordingly such candidates may choose to apply for the positions provided they meet the age criteria applicable to UR Candidates and indicate their category as 'UR'. Indian Oil Corporation Ltd. (Bongaigaon Refinery) being a Central Public Sector Undertaking, only those communities that are mentioned in the common list of OBC approved by Central Government shall be treated as OBC for the purpose of reservation.
- Candidates belonging to EWS category are required to submit an Income & Asset Certificate issued by Competent Authority prescribed under Point No. 5 of the Department of Personnel & Training's O.M. No. 36039/1/2019-Estt (Res) dated 31.01.2019. Format for the same can be downloaded from the website.
- SC/ST/PwBD candidates appearing for interview will be reimbursed single second class railway fare
 from the nearest railway station of the mailing address to the place of test/interview and back by the
 shortest route on production of ticket, provided the distance is not less than 30 KMs.
