## **Pre-Requisites:**

- 1. The offered premises area of approx. 2000-2500 sq.ft. should be available in single form on the same floor.
- 2. The building/premises should be located in or around City Centre / Bidhan Nagar / Muchipara area, having well connectivity through public transport / National Highway, and ready for occupation.
- 3. The building/premises should have good approach and visibility and not be in dilapidated condition.
- 4. The provision of lift within the premises is desirable, if it is located above ground floor.
- 5. The premises may preferably be furnished / semi furnished and ready to use.
- 6. The premises should have sufficient space for seating of 10/12 employees with provision for cabin and cubicles.
- 7. The premises should have availability of at least 3 toilets (including separate toilets for Male and Female) and 1 kitchen/ pantry.
- 8. The building/premises should not fall in water-logged area occurring mainly in rainy season.
- 9. The premises offered should have sufficient earmarked/reserved covered/open parking space for independent parking for minimum 7-8 cars and 2-3 bikes.
- 10. It should have provision of service water system along with sufficient water for canteen/pantry, housekeeping, toilets, washbasins, other cleaning purposes for 24 hrs.
- 11. It should have 3 phase main power supply with preferably LTDG power supply backup.
- 12. It should have safe, healthy, comfortable, durable and aesthetically pleasing ambience with provision of cross ventilation. Proper staircase and firefighting system should be available.
- 13. The premises shall be in Grade 'A' or Grade 'B' building with all statutory permission available for rent on commercial basis.
- 14. It must be able to accommodate the specific space and equipment needs as per the requirement of IOCL.
- 15. It should be readily accessible by all means of transport etc.
- 16. Office/property shall be rented for 03 years initially. The same can be extended for another 03 years as per requirement and mutual agreement on the same terms and conditions.
